15-0-0-6Fe is a liquid foliar nitrogen and iron supplement designed for application to turf and crops requiring supplemental nitrogen during the growing season.

Application Rates & Recommendations

Warm & Cool Season Turf: apply 3-6 oz per 1000 sqft for maintenance. Apply 8-12 oz per 1000 sqft for severe deficiency. Apply biweekly or as needed.

Ornamentals: apply 1-2 quarts per 100 gallons of water and spray to runoff as needed

Commercial Sod: apply 1-3 gallons per acre to green up turf as needed or before harvest

Use sufficient water for thorough and uniform coverage of foliage or soil. Always make a bench test to check compatibility of unknown mixes. Avoid tank mixing with heavy-phosphate fertilizers or alkaline products. Apply in early morning or late evening, avoid excessive heat or dry conditions. When applying by air, use a nonionic surfactant for improved coverage. Product has a low pH and will buffer tank mix when added first.
