### General Information

BRANDT CONVERGE 12-0-12 is a liquid fertilizer specifically formulated for all turf, ornamental, and horticultural applications.

### Rate Recommendations

For professional use, apply twice a month as a foliar spray early in the morning or late in the day for best results. Allow foliar sprays to dry thoroughly before irrigation to insure even foliar uptake.

#### For Warm or Cool Season Turgrasses

**Maintenance:** 5 to 7 fl oz per 1,000 sq ft or 1.75 to 2.50 gallons per acre

**Renovation:** 8 to 10 fl oz per 1,000 sq ft or 2.75 to 3.50 gallons per acre

**Overseeding:** 12 to 14 fl oz per 1,000 sq ft or 4.25 to 5.00 gallons per acre, applied at least semi-monthly after seeds have begun to germinate. Most effective when used as part of an overall overseeding nutritional program.

Optimum rate of application will vary depending on treatment interval, soil properties (such as pH, organic matter content, texture), weather conditions, time of year, plant species and its nutrient requirements. For best results, rollow soil/tissue test recommendation.

### Mixing and Handling Instructions

Fill spray tank with half of required water volume and begin agitation. Add products in this order, mixing thoroughly after each addition: adjuvants, pesticides, then fertilizers. Fill tank with remainder of water and continue agitation until spray solution is completely mixed. Check chemical mixture compatibility using a jar test prior to application.

Do not apply near water, storm drains, or drainage ditches. Do not apply if heavy rains are expected. Apply this product only to your lawn/garden. Check with your local cooperative Extension Agency to obtain specific information on local turf best management practices.
