SECTION 4 - FIRST AID MEASURES

TERATOGENICITY: Developmental effects only seen at maternally toxic doses.

MUTAGENICITY: Weight of evidence indicates the azoxystrobin is non-mutagenic.

SECTION 12 - ECOLOGICAL INFORMATION

ENVIRONMENTAL SUMMARY: This pesticide is toxic to mammals, fish and aquatic invertebrates. Do not apply directly to water, or to areas where surface water is present or to intertidal areas below the mean high water mark. Runoff may be hazardous to aquatic organisms in neighboring areas. Do not contaminate water when cleaning equipment or disposing of equipment washwater or rinsate.

Ground Water Advisory: Azoxystrobin can be persistent for several months or longer. Azoxystrobin has degradation products which have properties similar to chemicals which are known to leach through soil to ground water under certain conditions as a result of agricultural use. Tebuconazole is known to leach through soil into ground water under certain conditions as a result of label use. Therefore, use of AZOXY TEB in areas where soils are permeable, particularly where the water table is shallow, may result in groundwater contamination.

Surface Water Label Advisory: This product may contaminate water through drift of spray in wind. This product has high potential for runoff for several months or more after application. Poorly draining soils and soils with shallow water tables are more prone to runoff that contains this product. A level, well maintained vegetative buffer strip between areas to which this product is applied and surface water features such as ponds, streams, and springs will reduce the potential for contamination of water from rainfall runoff. Runoff of this product will be reduced by avoiding applications when rainfall is forecasted within 48 hours.

FATE: Azoxystrobin degrades rapidly in soil due to photolysis with a half-life of less than 30 days. Azoxystrobin is moderately mobile in soil.

SECTION 13 - DISPOSAL CONSIDERATIONS

Do not contaminate water, food or feed by storage or disposal.
