General Information

MANNI-PLEX GROW is designed for turf application for the prevention and correction of micronutrient deficiencies when used as part of a balanced fertility program.

Rate Recommendations

Turf (Commercial): Apply only to actively growing turf. For best results apply early morning or late evening.

Green & Tees: 3-8 fl.oz. per 1,000 sq.ft.

Fairways & Sports Turf: 1-2.5 gal. per acre.

Overseeding: 3 fl.oz. per 1,000 sq.ft. after germination.

Sod Installation: 3 fl.oz. per 1,000 sq.ft. at installation.

Optimum rate of application will vary depending on soil properties (such as pH, organic matter content, texture), weather conditions, time of year, general crop health and crop species. For best results, follow soil test or plant analysis recommendation.

Mixing and Handling Instructions

Apply in a minimum of 1 gallon water per 1,000 sq.ft. for ground spray equipment. MANNI-PLEX GROW may also be applied via fertigation systems.

Put 1/3 to 2/3 of total required water volume in tank. Add adjuvants, fertilizers and pesticides if desired and agitate until thoroughly mixed. Add recommended amount of this product and agitate until thoroughly mixed. Fill tank with remainder of water.

Caution: Check chemical mixture compatibility using a jar test prior to application. Be cautious when mixing with phosphate solutions.
