### General Information

BRANDT PLANT START is a concentrated liquid plant food formulated with seaweed extract to promote early growth and healthy root systems. This product is recommended for use as a supplement to a well balanced fertilizer program and is not meant to be a substitute for good cultural practices.

### Rate Recommendations

Field, Row and Vegetable Crops: Use 3-4 quarts per acre in planting or transplant water applied with seeder, plug mix or transplant machine.

Fruit, Tree and Vine Crops: Mix 2-3 quarts in 100 gallons of water. Use 1 gallon of solution to each tree at time of planting. For larger trees and shrubs, use 1 gallon of solution for each inch of trunk diameter.

Ornamentals: Mix 1-2 quarts in 100 gallons of water and apply as a drench for seedlings and transplants.

**Turf:** Greens and Tees - Newly seeded or grow-in — Use 1 quart per 10,000 sq.ft. in at least 10 gallons of water and repeat as needed. To deliver 1/2 lb of phosphorus per 1,000 sq.ft. – Mix 1 pint in sufficient volume of water and repeat as needed to enhance rooting. Hydroseeding — Mix at above rates with seed slurry mixture for ease of application.

Foliar Application: Use 2-4 quarts per 100 gallons of water. Cover foliage thoroughly to point of runoff.

# **Mixing and Handling Instructions**

Put 1/3 to 2/3 of total desired water volume in tank. Add adjuvant(s) and pesticide(s) if desired and agitate until thoroughly mixed. Add desired amount of BRANDT PLANT START and agitate until thoroughly mixed. Fill tank with remainder of desired water.

Caution: Check chemical mixture compatibility using a jar test.
