General Information

KaPre® KelpPlus is a concentrated natural, organic product that promotes stress tolerance in plants. It consists of the highest quality cold water kelp extracts and intermediate plant metabolites. KaPre KelpPlus also contains vitamin C as a food source for beneficial soil microbes and as a supplement to the plants own production of vitamin C.

Application Instructions

Apply only as directed. KaPre KelpPlus is recommended for soil or foliar application. For optimal results dilute one gallon in at least 100 gallons of water. KaPre KelpPlus can be mixed with most soluble fertilizers, herbicides, insecticides and fungicides.

Tree Maintenance

Mix 1 gallon per 400 gallons of water and apply with fertilizer to root zone with injection feeding equipment.

Ornamental Plant Maintenance

Dilute 1 to 100 in water (1 oz./gal.) and apply as a soil drench for stressed plants or spray diluted solution on foliage to runoff every 30-60 days to promote flowering.

Apply 6 oz. KaPre KelpPlus per 1000 ft².

Transplants

Dilute 1 to 100 in water (1 oz./gal.) and water into root zone at time of planting. In stress conditions, repeat 30 days after planting.

Turfgrass

Apply 1.5 to 6 ounces per 1,000 ft² every 2 weeks throughout the season.

Do not apply near water, storm drains or drainage ditches. Do not apply if heavy rain is expected. Apply this product only to your lawn and sweep any product that lands on the driveway, sidewalk, or street back onto your lawn.

In Virginia this lawn/turf fertilizer contains phosphorous and is only for nonagricultural use on (i) turf during its first growing season, (ii) on turf areas being repaired or renovated, and (iii) on turf where a soil test performed within the last 3 years indicates a phosphorous deficiency. This fertilizer is not for the routine maintenance of turf.
