### General Information

BRANDT 30-K is designed for application to all row, vegetable, and tree crops, and turf and ornamentals for the prevention and correction of potassium deficiency when used as part of a balanced fertility program.

### Rate Recommendations

#### Turf:

*Greens and Tees:* Apply 2-5 fl. oz. per 1,000 sq. ft. every 7-14 days or as needed to maintain healthy turf. Deficiencies may be corrected by doubling the normal maintenance rate per application.

*Fairways & Sports Turf:* Apply 3-8 fl. oz. per 1,000 sq. ft. every 7-14 days or as needed to maintain healthy turf.

**Ornamentals:** Apply a 1-3% solution by volume (1-4 fl. oz. per gallon, 12-51 fl. oz. per 10 gallons) and spray foliage to complete coverage as needed to maintain healthy potassium levels. For sensitive crops use lower rates.

**Crops:** For best results, use sufficient volume of water to yield a concentration of 0.5-2% BRANDT 30-K. For sensitive crops use lower rates.

*Tree Crops:* Apply 3-15 quarts per acre.

*Vegetable Crops:* Apply 2-6 quarts per acre.

*Row Crops:* Apply 2-8 quarts per acre.

### Mixing and Handling Instructions

Put 1/3 to 2/3 of total desired water volume in tank. Add adjuvant(s) if desired and agitate until thoroughly mixed. Add desired amount of BRANDT 30-K and agitate until thoroughly mixed. Add pesticide(s) if desired and agitate until thoroughly mixed. Fill tank with remainder of desired water. A jar test is a good field practice for evaluating compatibility of multiple chemical mixtures.

**CAUTION:** BRANDT 30-K has a pH between 11-13 and may not be compatible with pesticides that degrade in alkaline conditions.

Do not apply near water, storm drains, or drainage ditches. Do not apply if heavy rains are expected. Apply this product only to your lawn/garden. Check with your local Co-operative Extension Agency to obtain specific information on local turf best management practices.
