

GENERAL INFORMATION

A selected blend of modified vegetable oils and nonionic surfactants, MSO SELECT will improve the performance of spray applications by enhancing the penetration of active ingredients through the weather hardened cuticle of targeted pests to the mode of action site. MSO SELECT slows drying time which enables better uptake of the pesticide and more complete pest control.

DIRECTIONS FOR USE

Follow the directions on all pesticide labels. Use MSO SELECT with any pesticide that requires or suggests the use of an MSO, ESO, MVO or other oil-based adjuvants. The first time the product is used, perform a compatibility (jar) and phytotoxicity test before application.

USE RATES

- Herbicides, defoliant, desiccants: 0.5-1% v/v
- Insecticides, fungicides, miticides: 0.0625-0.125% v/v
- Small spray equipment: ½ ounce per gallon of finished spray solution
Must not exceed 5% v/v of total spray solution.

MIXING INSTRUCTIONS

Follow the mixing order established on the pesticide label. If instructions are not provided, follow these recommendations:

1. Fill spray tank more than half full of water.
2. Add dry flowables (DF) and wettable powders (WP).
3. Agitate until thoroughly dispersed.
4. Add all other active ingredients, adjuvants and MSO SELECT.

Note: For best results, apply within 36 hours of mixing.

STORAGE AND DISPOSAL

Storage: Store in a cool, dry place. Store in original container only. Do not add anything to the container. Keep container tightly sealed when not in use. Do not store near fire, flame or other potential sources of ignition. Do not contaminate water, food or feed by storage or disposal of this product. For optimal storage, store between 40° and 90° F.

Disposal: Do not reuse empty container. Triple rinse (or equivalent) during mixing and loading. Recycling decontaminated containers is the best option of container disposal if allowed by law.
