**General Information**

Prudent® Green is recommended as a supplement to a well-balanced fertilizer program only.

Prudent® Green is intended to supply nitrogen as well as protect sensitive turfgrass from damage resulting from exposure to sunlight and the resulting UV radiation. When applied to turf, it forms a protectant film.

**Application Guidelines**

For best results, apply Prudent® Green during the morning hours and allow the product to dry completely prior to irrigating or rainfall. Prudent® Green should be diluted in sufficient water to cover and adhere to all turf surfaces, especially those exposed to direct sunlight.

Under normal conditions of turf growth during the growing season, applications should be repeated every 7 to 21 days, depending on the use rate and weather conditions. Additional applications may be required under conditions of persistent high temperature, increased UV exposure, rain events or other circumstances which may deteriorate the coverage of the turf to be protected.

*Prudent® Green can stain clothing and porous material. Contact with those materials should be avoided.*

**Compatibility**

Do not mix with pesticides or other chemicals without a compatibility test. An adequate test for compatibility involves mixing in a small container the proper proportions of the product with water and the other ingredients. Agitate and let stand for one hour. If a precipitate forms, then apply the products separately. ALWAYS add Prudent® Green as the last ingredient.

**Application Rates and Timing**

Make first application prior to the onset of stress or temperatures over 80°F (27°C). Use lowest application interval when low humidity and intense sunlight are forecasted. Continuous and uniform coverage is recommended to ensure improved turfgrass health.

**Greens:** Apply 1.5 to 4.0 ounces per 1,000 ft² (2.1 to 5.6 quarts per acre) every 7-14 days

**Tees/Fairways:** Apply 1.5 to 4.0 ounces per 1,000 ft² (2.1 to 5.6 quarts per acre) every 14 days

**Roughs/Bunkers:** Apply 1.5 to 4.0 ounces per 1,000 ft² (2.1 to 5.6 quarts per acre) every 14-21 days

Note: Use a minimum of 50 gallons of water per acre.

**Mixing Instructions**

**SHAKE WELL BEFORE USE.** Fill spray tank with 50% of the water volume before adding Prudent® Green. Add the full rate of Prudent® Green to the tank and then the remaining water with constant agitation.

**Storage Instructions**

**AVOID FREEZING.** It is recommended that Prudent® Green be stored in fiberglass, polyethylene, or polyolefin. Do not stack pallets.
